
2. APPOINMENT & RETIREMENT OF TRUSTEE:

- i. If a request is made in writing to a Trustee to retire by all the other Trustees for the time being in office and also constituting the majority of the Board.
6. Vacancies occurring due to the reasons mentioned above shall be filled up by nominating new Trustee/Trustees by the sitting members of the Board including the Chairman unanimously. Provided the new Trustee shall be a person having faith and dedications to the Aims and Objects of the Trust stated above.
7. The ownership and control of the properties of the Trust shall vest in the Board of Trustees and the movable or immovable properties will be in the name of the Trust.
8. The Chairman of the Trust shall preside over the meetings of the Trust. All decisions shall be taken by resolutions passed by the majority and the Chairman shall have a casting vote in case of tie.
9. Meeting of the Board of Trustees.
 - a. The Board of Trustees shall hold ordinary meetings at least one in 6 months.
 - b. The quorum of the meeting shall be minimum 3 if the total members of Trustees are 7 and in case the number of the Trustees has been increased by Trust as provided in clause above the quorum shall be 5.
 - c. The Chairman or the Secretary shall have the powers to call the meeting of the Board of Trustees.
 - d. A special meeting can be called by the Chairman or the Secretary in case of some urgency or on the requisition of any two members of the Board of Trustees.
 - e. An ordinary meeting can be called with a prior notice of 7 days to the Trustees where as a special meeting can be called with a notice of 24 hours.
 - f. When a meeting is not feasible due to some reasons, a decision can be taken by the Board of Trustees by circulating the minutes to the members of the Board of Trustees.



- g. All the decisions shall be taken by the Trustees by majority of votes.
- h. All the members of the Board of Trustees shall have equal powers in decision making except the Chairman who shall have a casting vote as provided in clause 8 above.
10. The Secretary shall maintain upto date record of the Trust. The minutes of the Board of Trustees shall be recorded by the Secretary and Signed by him as Secretary. The minutes of the meeting shall be read over to the members of the Board of Trustees in the ensuing meeting and shall be confirmed by putting their signatures/thumb impressions.
11. The Treasurer shall be responsible for maintenance of the Trust funds.
12. Funds of the Trust:
- The Trust will raise funds for achieving its aims and objects by contributions from the Trustees, donations from general public or philanthropic institutions, NGOs, grants from the Government or semi government institutions raising loan from public & financial institutions if need be, income from the properties of the Trust and the like.
 - The Board of Trustees may invest the Trust money for generating revenue for the achievement of the aims and objects of the Trust. However investment shall be in the manner provided in the Act.
 - The Trust money shall be deposited in any bank by opening bank accounts in the name of the Trust which will be opened by any three members of the Trust including the Chairman and operated by any two Trustees as may be decided by the Board of Trustees from time to time.
 - Expenditure incurred by any member of the Trust for the purpose of the Trust shall be reimbursed by the Trust.
13. The accounts of the Trust shall be regularly maintained by the Treasurer who shall be answerable to the Board of Trustees. The







accounts so maintained of the preceding period after the last meeting shall be put before the Board of Trustees in every meeting for approval. An annual balance sheet of the Trust shall also be prepared by the Treasurer which will be put before the Board of Trustees in the ensuing meeting of the Trust. A year for this purpose shall be deemed to be from 1st April to 31st March of the next year. However, if need, the services of an accountant or chartered accountant will be availed of by employing some competent person as such from outside the Board of Trustees who shall not be deemed to be a member of Board of Trustee.

14. The Treasurer shall also maintain a register of movable and immovable properties of the Trust.
15. The Board of Trustees may constitute committees for the management of different institutions/units created by the Trust or work taken up the Trust comprising of members and office bearers from general public outside the Board of Trustees. Provided that the Chairman/President of such committee constituted by the Board of Trustees shall be one of the members of the Trust as decided by the Board while constituting such committee; The Board of trustees shall frame by-laws/Rules of business of such Committee. The Managing Committee so constituted shall work under the control and supervision of the Board of Trustees within the frame work of the Rules of Business and shall be answerable to the Board of Trustees. Provided that such Management Committees shall be constituted in consonance with the statutes of the concerned State.
16. The Trust shall sue or be sued through the Chairman or the Secretary of the Trust and the Board of Trustees may authorize any of the members of the Trust to represent the Trust on its behalf in any court of law, Tribunal, authority of the Government any bank or any other institution or authority constituted under any statute of the state. The Trust shall be responsible for the acts of omissions of such authorized person. If he works within the authority given to him/her. Such authorized person shall not be personally liable for




17. The Trust may buy or take or give on lease or mortgage any property movable or immovable for achievement of the aims and objects of the Trust for which the Trust may authorize any of the Trustees.
18. The Trust may collaborate with any Trust or society, N.G.O or Government agency of the like nature for achievement of its aim and objects.
19. The Trust may engage employees for execution of the works taken up by the Trust. The employees engaged by the trust or any committee constituted by the Trust will be employees of the Trust. The salaries/remunerations of such employees shall be fixed by the Trust.
20. Amendment in the deed- The Board of Trustees may propose amendment in this deed by the resolution adopted by at least two third majority if necessity arises due to change of circumstances but it will be passed with minimum five Trustees in the meeting.

4. POWERS OF BOARD OF TRUSTEE:


THE BOARD OF TRUSTEES SHALL HAVE THE FOLLOWING POWERS:

1. To manage the properties, assets and funds of the Trust, from time to time such regulations (not being inconsistent with this deed) as they may think fit for and necessary for the purposes of such management and control or in connection with the execution of any of the subject herein contained or powers here by vested in them and may rescind or alter any such regulation.
2. To accept donations, contributions, grants, subscription in cash or in kind from any person, company, firm, association, organizations, government, non government or semi government agencies, national or foreign funding agencies, family Trust, or corporate







- bodies for furtherance and achievement of the objectives of the Trust.
3. To appoint a Settler, when necessary.
 4. To review the affairs of the Trust.
 5. To appoint officers and members of staff for the Trust and to prescribe their condition of service.
 6. To open current or CC A/c in any Bank.
 7. To raise loans with or without security or to invite donation and financial help.
 8. To receive the honorarium or salary against his/ her services or involvement in any of the project or programme run by the Trust, which must be decided by the Board of Trustees and approved by the Chairman /Chairperson.
 9. To authorize person (s) to sign or execute documents on behalf of the Trust.
 10. To grant Special Power of Attorney to represent the Trustees in connection With any legal or other proceedings.
 11. To acquire Land or building on lease or way of purchase.
 12. To compromise, compound or refer to Arbitration all actions, proceedings and disputes relating to Trust property or properties.
 13. To sell or give on rent/lease or on hire any immovable or movable property of the Trust for some certain period (s) on such terms and conditions as the Trustees may think fit and proper from time to time.
 14. To open any type of bank account (S), in the name of the Trust or institution (s) or programme (s) run by the trust with any scheduled bank, (s) or post office (s) and to be operated by the authorized signatory or signatories as Board of Trustees shall think fit and proper to authorize any person or persons, unless and until determined otherwise the such bank account(s) shall be opened and operated jointly with signatures of any two members of Board of Trustees as decided and passed by Board of Trustees. The financial year for the Trust shall be 1st April to 31st March and the accounts

- of Trust or institution (s) or programme (s) run by chartered accountants to be appointed by the Board of Trustees and the fee for auditor(s), if paid, shall be a part of outgoing amounts from the Trust Funds.
15. To give guarantee of the assets and property of the Trust, including the bank guarantee on behalf of the Trust to corporate bodies, persons, firms, institutions, bank as Trustees may decide from time to time. The Trustees shall not be personally liable for such guarantees.
 16. To gift, lease, and transfer the immoveable and moveable properties of the Trust.
 17. To appoint lawyer, pleader, advocate to file and defend suit or suits filed for and against the Trust and or in the name of the Trust and also file suits for financial and other disputes or dues with different parties and signed executed and to remove at any time any such application, petition documents for such proceedings and delegate powers to the officers), employees), staff(s) and Trustee(s) for such proceedings) as required from time to time.
 18. To appoint from time to time on such terms and conditions as they may determine a Principal, Executive Director, Director(a) and other officer(s) Teaching staff or members(s) of staff for carrying out the activities of the Trust and to remove at any time any such Principal, Executive Director, Directors) and other officer(s) or members(s) of Teaching staff.
 19. All questions relating to the management of the Trust or the exercise of the powers vested in the Trust shall be decided at a meeting or, if necessary and expedient, by circulation. Every such question shall be decided by a majority of the Trustees present and voting in any meeting of Board of Trustees or by the circulation, as the ease may be and any action or decision of such majority shall be as valid as if it was done or made by the all Trustees. The Chairman Chairperson shall have a casting vote.

20. In Case of occurrence of any vacancy amongst the Trustees because of death, resignation or incapacity of any Trustee or any other cause, a new Trustee may be appointed to fill the vacancy by absolute majority of existing Trustees.
21. In case of death his/her legal heir will have the first preference to become the Trustee.
22. All matters not provided for in this Trust deed but necessary for the administration of the Trust of for giving effect to the objectives of the Trust may by resolution(s) made by the Board of Trustees will be carried by a special majority of two third of total number of the Trustees.


5. OBJECT & BENEFITS:


- 1) To create an institution which provides a quality education.



The Trustee may resign as Trustee at any time without assigning any reason by giving not less than thirty (30) days prior notice to that effect to the Board provided that no such resignation shall be effective until (a) a successor to the Trustee is appointed by the Board within 30 days notice period from the receipt of the Trustee's notice of resignation and (b) all of the relevant documentation in respect of the Trust and complete control over the Trust Fund (including updated statement of accounts and investment of the Trust Fund) have been transferred to such successor.


8. DISPUTE RESOLUTION:
