





- If a request is made in writing to a Trustee to retire by all the other Trustees for the time being in office and also constituting the majority of the Board.
- 6. Vacancies occurring due to the reasons mentioned above shall be filled up by nominating new Trustee/Trustees by the sitting members of the Board including the Chairman unanimously. 


